Reservations are not considered final until this permit has been signed by the applicant and State Park staff, and all fees due have been paid. Depending on the nature of the park usage a special event permit and fee may also be required. All areas remain open to the public and no exclusive right of use exists unless specified. Any violation of conditions revokes permit and fees are forfeited by permittee.
